Subject: Taking necessary action against Damoh Police for furnishing false and frivolous document(s) to the Commission.

National Commission for Protection of Child Rights (hereinafter referred to as the Commission) is a statutory body constituted under Section 3 of the Commission for Protection of Child Rights (CPCR) Act, 2005 to protect the child rights and other related matters in the Country. The Commission is further mandated to monitor the proper and effective implementation of Protection of Children from Sexual Offences (POCSO) Act, 2012; Juvenile Justice (Care and Protection of Children) Act, 2015 and Right to Free and Compulsory Education (RTE) Act, 2009. In one of the functions laid down under Section 13 of the CPCR Act, 2005, the Commission has been assigned with the function to examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation. The Commission also has the powers of Civil Court trying a suit under Section 14 of CPCR Act, 2005 and Code of Civil Procedure, 1908.

- The Commission has been in receipt of a complaint dated 21.11.2022 wherein it was brought to the notice of the Commission that, priest of "Kerala Missionary Institute" situated at Damoh, Madhya Pradesh was involved in an illegal conversion and sexual harassment of minor girls. It was also informed that CSP Abhishek Tiwari recorded the statement of the minor but did not register an FIR.
- That on 22.11.2022, the Commission issued a notice to the Superintendent of Police, Damoh in the said complaint vide F. No. MP-1 view of the above, the Superintendent of Police, Damoh was called upon Summons to appear in person before the Commission to furnish explanation into the said complaint on 5th December 2022 at 1400 hours vide Summons dated 30.11.2022.
- That the Commission is in receipt of an Action Taken Report dated 11.12.2022 from Superintendent of Police, Damoh wherein an Annexure has been attached containing the

Panchnama, thereby showing that S.I. Abhishek Patel was present at Vikaspuri Colony, Delhi on 05.12.2022 at 4:20 PM. (Copy of the Panchnama dated 05.12.2022 enclosed)

- 5. That on 05.12.2022, Shri Abhishek Patel, S.1 appeared before the Commission with authority letter on behalf of the Superintendent of Police. The S.I. appeared before the Commission at 2 PM and was present in the Commission till around 3:15-3:30 PM. It is noticed that since S.I. Abhishek Patel was present in the summons proceedings before the Commission on 05.12.2022 till 3:15-3:30 PM, the Panchnama annexed in the ATR sent by the Superintendent of Police is false and frivolous.
- 6. In light of the above, the Commission is requesting your good offices to initiate an action against Damoh Police for filing false and frivolous documents in a matter before the Commission.
- 7. An action taken report in this regard may be sent to the Commission within 07 days from the receipt of this letter.
