Petitioner has been transferred by order dated 05.07.2019. Petitioner has joined as District Programme Officer, Niwadi. It is submitted by the learned counsel appearing on behalf of the petitioner that there is no staff to work at Niwadi, in infrastructure is also not there. It is submitted by him that two posts are vacant at Shivpuri and Datia. Petitioner has also preferred a representation before the authority concerned which is not considered till today.

In view of the aforesaid facts and circumstances of the case, it is ordered that representation preferred by the petitioner Annexure-P/8 will be considered and decided by the authority concerned by reasonable and speaking order within a period of 30 days from the receipt of certified copy of the order passed today.

Shri Ajeet Kumar Rawat, learned counsel for the petitioner.

Shri Swapnil Ganguly, learned Deputy Advocate General for the respondents/State on advance copy.

The petitioner was transferred to a newly created District - Niwari on the post of District Programme Officer. The petitioner filed a writ petition before this Court - **W.P. No.3748/2020** raising two fold grievances; that the petitioner has been transferred to a place where there is no post of District Programme Officer, and further the petitioner is not being paid her salary.

This Court disposed of the said writ petition by order dated 18-02-2020 and directed the respondents to consider and decide the representation of the petitioner within a period of 30 days from the date of receipt of the order. The respondents have decided the representation of the petitioner and made arrangement for payment of her salary.

The learned counsel for the petitioner submits that the petitioner should have been posted at a place where the post is vacant. Since the arrangement has been made for payment of salary, there is no illegality in the impugned order in deciding the representation of the petitioner, as respondents have already made arrangement for payment of salary. The respondents will continue to make payment of salary of the petitioner in accordance with the Rules in future also.

With the aforesaid observation and direction the **writ petition stands disposed of.**
