Subject: Action Taken Report Called for(ATR) -577/12/39/2026.

Sir/ Madam,

The complaint/ intimation dated 24/03/2026, was placed before the Commission on 30/03/2026. Upon perusing the same, the Commission directed as follows:

Notice under Section 12 of the PHR Act,1993

The Protection of Human Rights Act, 1993, has entrusted the National Human Rights Commission (NHRC), India, with the responsibility of protecting and promoting the rights of all human beings in the country and having the powers of a civil court for inquiry u/s 13 of the PHR Act, 1993.

The complainant, a state vice president of National Student Union of India,, Madhya Pradesh alleged that the Vellore Institute of Technology (VIT), Bhopal University is misleading students and parents by using "Bhopal" in its name despite being located 100 km away in Sehore district. This geographic misrepresentation reportedly resulted in students feeling cheated during admissions. Furthermore, the complainant highlighted administrative negligence, including the operation of an illegal clinic and a history of campus unrest. The complainant has sought the intervention of the Commission in the matter and requested the immediate removal of "Bhopal" from the university's title, a high-level inquiry into irregularities, and coordination with the Madhya Pradesh government.

The allegations made in the complaint prima facie seem to be violations of the human rights of the victims.

The Bench of the National Human Rights Commission, presided by Shri Priyank Kanoongo, Hon'ble Member, has taken cognizance u/s 12 of the Protection of Human Rights Act, 1993, in the matter. The Registry is directed to issue a notice to the Chairman, University Grants Commission, New Delhi and the Principal Secretary, Department of Higher Education, Govt. of MP, Bhopal, with directions to get the allegations made in the complaint inquired into and to submit an Action Taken Report within two weeks for perusal of the Commission. A copy of the complaint is attached herewith.

The authority is also directed that a copy of the report in the matter be also sent on e-mail: bench-mpk@gov.in

2. Accordingly, I am forwarding herewith a copy of the complaint/ intimation as an attachment for taking appropriate action in the matter as per the directions of the Commission. It is requested that an Action Taken Report be sent to the Commission within 2 weeks from the date of receipt of this letter.
