2. The officers mentioned above shall be relieved immediately and must join at their new place of posting on or before 6<sup>th</sup> July, 2026. No representation whatsoever shall be entertained before the above-mentioned officers join at the new place of posting.
3. By and large, the officers have been posted to GST/CX Zones only. The Placement in certain GST/ Customs CC Zones is done including combined vacancy position of some of the Customs (P) Zones. Chief Commissioners/ Chief Commissioner in terms of para 3.2 of Transfer / Placement Guidelines, 2018.
  - (i) Delhi GST – Delhi Customs Zone, Delhi Cus (P) Commissionerate and CCO of Delhi CC (P) Zone.
  - (ii) Jaipur GST Zone – Jodhpur Cus (P) under Delhi Cus (P) Zone.
  - (iii) Chandigarh GST Zone – Amritsar & Ludhiana Cus (P) Commissionerate under Delhi Cus (P) Zone.
  - (iv) Lucknow GST Zone – Lucknow Cus (P) Commissionerate under Patna Cus (P) Zone.
  - (v) Ranchi GST Zone – Patna Cus (P) Zone Commissionerate and CCO of Patna Cus (P) Zone.
  - (vi) Chennai GST Zone- Chennai Customs Zone, Trichy Cus (P) Zone & CCO of Trichy Cus (P) Zone.
4. The Zones concerned shall send the compliance regarding relieving and joining of the above officers to the Board (with a copy endorsed to ADG (HRM-II), DGHRD) by 10<sup>th</sup> July, 2026.
5. All the representations received till date regarding transfer and posting in the grade of Deputy Commissioner / Assistant Commissioner of Customs and Indirect Taxes stand disposed of.
